Mission

The mission of Moorhead Fire and Rescue is to save lives and property from the ravages of fire, medical emergencies, hazardous materials incidents, and natural disasters in the most effective and efficient manner. These protective services include fire suppression, fire prevention, public education, inspection and plan review, and fire cause determination. It is the City of Moorhead's intent that all citizens be treated equitably with regard to its Fire and Rescue resources in order to ensure the well being of the community.

Philosophy of the Moorhead Fire Department

We are a responsive, skilled and well-equipped department with the goal of intervening in early stages of a fire or an EMS incident to minimize the event to the room of origin; or to take quick preventative measures to help a citizen survive a life-threatening accident or illness.

Vision

- Provide high quality fire suppression and prevention services second to none in the City of Moorhead
- Serve as the "model" of quality standards in areas of response time, safety, staff and technology
- Serve as the "model" of customer service for Moorhead Residents



The Moorhead Fire Department unsuccessfully applied for a federal Staffing for Adequate Fire & Emergency Response (SAFER) grant to add three new firefighter positions in 2005. A second unsuccessful grant application was made in 2006, and third apparently unsuccessful application was made in 2007. The City Council authorized and fully funded three new positions for 2008. On February 9th, 2008 we were awarded the 2007 SAFER Grant and added a total of six new Firefighter positions. These positions were six of the twelve positions necessary to open a third station, a need placed in writing in the Moorhead Fire Department 2007-2010 Strategic Plan.

Part III: BREAKDOWN OF STRUCTURE FIRES AND OTHER FIRES AND INCIDENTS

2008 NOTES

- February 8, 2008 the Public Safety Breakfast Club sponsored "The Day the Bridge Fell" Presentation given by Minneapolis Fire and Emergency Management at MSUM. The presentation was about the lessons learned from the I-35 W Mississippi River bridge that collapsed on August 1, 2007 killing 13 people and injuring more than 145.
- May 20, 2008 the Public Safety Breakfast Club sponsored the presentation on the Northwood Tornado given by the Northwood City Administrator. Northwood, ND experienced an EF4 rated tornado on August 26, 2007, killing one person and injuring 18 others.
- Chief Brunacini Training/Visit June 4, 2008
- 2006 Legislation passed that effective 08/01/2008 all existing single family homes shall be equipped with approved CO alarms (Minnesota Statute).
- CO Detector Program (give away of CO Detectors) announced to the Public, October 27, 2008. Fifty CO detectors were donated to the Moorhead Fire Department by the Minnesota State Fire Marshal's Office to place in homes where they were needed. They were provided on a first-come, first serve basis and installed by Firefighters to promote citizen safety.
