

City of Moorhead Downtown Transit Circulator Subcommittee Meeting Summary April 21, 2015 – 7:00 a.m. Boardroom – City Hall

1. Define the Scope and Purpose of the Downtown Transit Circulator Subcommittee (DTCS)

- a. Steve Gehrtz, Moorhead City Council (MCC), was appointed chairperson of the DTCS.
- b. Joe Nigg, City of Fargo Staff, provided an overview of the history of the proposed transit route. The proposed route is designed on a 15-minute turnaround time, with the goal of reaching several Downtown Fargo locations and the Moorhead Center Mall (MCM). Joe reviewed amenities within a ¼ mile walking buffer. While not all inclusive, it does illustrate the opportunities with the proposed route. He provided a handout of City of Fargo owned parking facilities and their current capacity.
- c. Dave Piepkorn, Fargo City Commission (FCC), shared that the cost for one Fargo bus is \$130,000/year to operate the route.

2. Background Information

- a. Joe Nigg provided information on Routes 31 and 34 (NDSU routes) as two circulator route examples. The proposed circulator route is a start, and additional resources can be added to it. The route touches locations on the Fargo side that were determined to be the best locations to begin service.
- b. Information was provided in response to a question about Routes 31 and 34 ridership statistics and if there is an estimate for ridership for the proposed route. Joe Nigg responded that a marketing/outreach education effort would be necessary to get resources in place to market the route and recruit riders. Specific estimates have not been developed for the proposed circulator.
- c. Nancy Otto, Moorhead City Council, expressed support for the proposed route, and suggested adding the Hjemkomst Center as a stop addition to keep the route within the 15 minute timeframe. Flyers and other outreach materials to get the word out about the route will be crucial to its success.
- d. Mike Hahn, Downtown Community Partnership (DCP), stated that a commitment to the route was needed over the long-term to connect the two downtown districts. DCP has committed to promoting the route and marketing it for both sides of the River.
- e. Steve Gehrtz suggested that slight alternations to the route could be beneficial for Moorhead.

3. Future Meeting Agenda Topics

- a. Joe Nigg will add the Hjemkomst Center and US Bank/Center Ave. as stop additions and refine the concept further with a ½ page summary to be communicated back to the DTCS and cities of Fargo and Moorhead.
- b. Dave Piepkorn suggested creating an opt-out opportunity for the Center Mall in the event they no longer desire the service in the future.
- c. Next steps will be to draft an alternate circulator route, clarify stops on the existing route, and outline marketing/signage.
