Capture the Sun™ Community Solar Garden

A community solar garden is a collection of shared solar panels for individuations who want to participate in solar energy production in a community location.

How does the Capture The Sun™ Program work?

A Moorhead Public Service (MPS) electric customer can purchase the output from one or more solar panels (also

referred to as "Solar Interests") in the Capture The Sun™ Community Solar Garden, which will be constructed between the two MPS Capture The Wind® turbines in north Moorhead. MPS will construct the solar garden, perform necessary ongoing maintenance, and deliver the energy to the customer's home or business.

The current cost of each solar panel, or Solar Interest, is \$480, for which the participating



customers will be billed in 12 equal payments their MPS utility on bill. The purchase of the output from the solar panel(s) provides the customers with the annual energy production from the solar panel(s) for 20 years. The participating customers will see

their MPS electric bill decrease by the amount of energy the solar panel(s) produces, less any maintenance costs.

Fire Department

Outdoor Burning

Outdoor burning of natural vegetation to dispose of leaves, branches, and natural vegetative material is allowed under certain circumstances alona river lots and rural areas of the Oakport Neighborhood. Permits are free and available at the Fire Department Annex at 111 12 St N, Monday through Friday from 8:00 -4:30 pm. Before seeking an open burning permit, utilize the Public Works Department to pick up branches, leaves, and other yard waste which is offered free of charge.



Bonfires

Large, outdoor fires specifically for community activities and special events require a permit from the City of Moorhead Fire Department.

Outdoor Warning Sirens

Outdoor warning sirens are intended to notify people that conditions exist which may require taking action for safety. This could include severe weather, hazardous chemical spills, or other threatening natural or man-made conditions. When sirens sound, seek additional information sources to determine the nature of the problem and actions to take. Television, radio,

Recreational Fire

Outdoor burning of materials other than rubbish contained in an outdoor fireplace/fire pit is considered a recreational fire. A permit is not required under the Minnesota State Fire Code, but the following conditions must be met:

- 1. Fire must never exceed three feet in diameter by two feet in height.
- 2. Fire must be at least 25 feet from any structure or combustible material (including decks).
- 3. A garden hose hooked to a reliable water source or a fire extinguisher with a 4A rating must be immediately accessible.
- 4. Fire must be constantly attended.
- 5. Only natural, vegetative material may be used.
- 6. The Fire Department may order extinguishment if determined necessary.
- 7. The Fire Department recommends a screen over the fire to contain sparks.

Two new sirens will be placed in the Oakport Neighborhood and at the Moorhead Municipal Airport. Sirens are tested at approximately 1 pm on the first Wednesday of each month. Fargo's sirens are tested within a few minutes of Moorhead's, so you may hear multiple activations in the area.



Outdoor Warning Sirens are not designed to be heard indoors. Sign up for CodeRED® phone, cell phone, e-mail, TDD/TTY, or text message alerts. It's fast, easy, free, and can save your life. Go to ecnetwork.com [Resident Enrollment] or call the Fire Department at **218.299.5298** to sign up.

Summer Youth Passes Available

Get kids to all of their summer activities without all the chasing! Youth (K-12) can take unlimited rides on MATBUS fixed routes from June 1 through August 31 for just \$26. Each bus has a bike rack on the front, so you can bike and bus.

Free Rides to the Public Library

MATBUS offers free rides to youth (K-12) going to and from the Fargo, Moorhead, or West Fargo public libraries. Youth can show the driver their library card from June 1 through August 31.

Routes drop off at the Ground Transportation Center in Downtown Fargo. Daytime buses run from 6:15 am to 6:45 pm and night buses run from 6:45 pm to 11:15 pm.

Park and Ride Lots

Moorhead Center Mall (MCM): From the shelter on the north side of Center Ave, take Route 4 at :29 or :59 after the hour. Return from the GTC to US Bank (across from MCM) on Route 4 at :18 or :48 after the hour.

K-Mart (Highway 10): From the K-Mart entrance, take Route 4 at :14 or :44 after each hour. Return to K-Mart on Route 4 from the GTC at :15 or :45 after the hour.

Stormwater

Stormwater runoff from rain and snow flows over rooftops, streets, driveways, sidewalks, parking lots, and yards to storm drains. As it flows it picks up pollutants such as pet waste, salt, pesticides, fertilizer, oil and grease, trash, and other pollutants. The water drains directly into nearby ditches, stormwater ponds, and the Red River without treatment.

Please check for leaks and responsibly dispose of all pollutants to help keep our City and river clean. If a hazardous spill has occurred, call 911.

Tips

- Dispose of chemicals, motor oil, and other contaminates at the Clay County Hazardous Waste Facility - www.co.clay.mn.us.
- Never hose down pollutants or illicit dischage (non-stormwater discharge) into a storm drain, street, or gutter.
- Report illicit discharge at 218.299.5886 or stormwater@cityofmoorhead.com.

City on the Red

The City maintains Flood Insurance Rate Maps (FIRMs), elevation certificates, FEMA Letters of Map Amendment, and other flood related information on file and available to lenders, insurance agents, real estate agents, and citizens. Call and speak with the Floodplain Manager or use the interactive GIS mapping tool to determine if your property is in the 100-year floodplain.

Floodplain Development Permit

Before you fill or build a structure a Flood Development Permit is required for lots touched by the 100year floodplain. Permits must be issued prior to performing any work.

Building Improvements

If the proposed improvements on your home equal or exceed 50% of the building's market value, before the start of construction, the existing building and any proposed addition must comply with floodplain standards.

If the proposed improvements are the result of damage and the cost of improvements equals or exceeds 50% of the market value, the building must comply with floodplain standards. This includes damage from any origin and from multiple events. There isn't a time limitation for substantial damage, so the cumulative cost accrues indefinitely. Building improvements or repairs must include all costs, including but not limited to cost for construction materials and labor.

Flood Mitigation Projects

Your neighborhood may already be protected by a levee or a floodwall, but currently only the Brentwood/Rolyn Acres levee is accredited by FEMA. The City received a Letter of Map Revision (LOMR) for accreditation of the Horn Park Flood Mitigation Project that will take effect on August 14, 2015 at the conclusion of a statutory appeal period.

In the future, the Engineering Department plans to submit additional LOMR applications for accreditation for the following projects: 50 Ave S, Moorhead Country Club, and the Woodlawn Park Area. Visit www.cityofmoorhead.com for areas affected and status updates.

Natural & Beneficial Functions

Floodplains provide natural and beneficial functions including acting as an erosion control buffer and open space so further flood damage does not occur. Native plants are best suited for floodplains.

- Deep root systems that resist erosion and stabilize the shoreline
- Turf grass has a shallow root system and commonly erodes
- Sediment is the #1 pollutant in our river •

Drainage System Maintenance

Keeping ditches and storm sewers free of debris can dramatically improve run-off capacity, as well as reduce the possibility of blockage that contributes to flooding.
